Agenda

- 11 full papers are expected at this time from the original list of 13.

One paper has already gone to reviewers and at least one more has been submitted. Others authors have asked for more time. Agreed new deadline 15 February with a backstop of the end of February for authors that do not make the deadline of the 15th. It is likely that one paper will require longer time than this.

Papers are to go to review as they are submitted (don't need to wait for them all to come in). Reviewers will be asked to complete the review in 2 weeks. By 15 March reviews should be completed so that the conference can have reviewed papers (even if amendments have not been completed). This would mean the special issue could be the June or the July/Aug issue of the journal.

Authors should submit their articles through the regular channel (online via the journal website) but say that the paper is for the FP1004 special issue in the comments field.

The journal is 144 pages in length but this is a target rather than a fixed amount. It can be slightly longer or shorter if necessary. The typical journal article is 8 pages long in the journal format (which is 18 full papers). Papers for the special issue will probably be a bit longer as authors have not been advised on length. In the journal format, one page of text is about 800 words. 12 pages of 'typical' word format document (12 point font) would be about 8 pages in the journal format.

Do we need a contingency plan if there is not enough to fill the journal? STSMs could provide brief originals, but none have been asked yet. **Made a list of authors to ask and Kay-Uwe will contact**

them. Any brief originals that don't fit into the special issue of the journal could go into another issue.

An editorial is required from Richard – but this is the only task as guest editor

Jan Willem has the list of reviewers and will make the decision about who to ask for each paper as they are submitted. Two reviewers are required for a regular article and one or two for a brief original. This means some reviewers will be asked to review two papers.

Important: Colour costs 800 Euro per paper. Jan Willem to check if digital issue can be colour if the printed issue isn't. If necessary, colour photographs and diagrams could be attached to the online article as 'supplementary digital information' (as can videos).

300 printed issues. Jan Willem to get a quote from Springer

3. Lisbon Meeting

A new programme was worked out starting on the morning of the first day (as people will not be able to travel on the same day anyway). A technical tour of LNEC was added at the end. New programme has been distributed and is on dropbox.

The venue was inspected and declared excellent.

~70 COST invitees + research students and industry

Presenters – will be asked in advance to send copies of powerpoint slides to be printed (simply) for the delegates. It would be confusing to give the delegates working copies of the papers.

Decided to add a 20 Euro per day registration fee and 30 Euro (optional) conference dinner fee. The registration fee and the 20 Euro per person per day organiser support (up to 5,000 Euro max) will be enough to cover running costs. Delegates can easily stay in good hotels less than the reimbursement rate so they do not need to be out of pocket.

Decided to recommend two hotels to delgates: Hotel Lutecia and Hotel Roma by Roma-Areeiro railway station. This is about 25 minute's walk from LNEC and not too far from Roma metro station. Rooms are available for less than 100 Euro per night with breakfast.

Not done yet: sorted the papers into the schedule or decided on moderators for sessions

List reviewed. It looks like the budget will not be fully used because STSMs are not costing as much as the estimate. Applications are still coming in though. Spare funds can be carried to the Training School.

AOB. Training school

3 days. 15,16,17 April in Portobello, not far from Edinburgh city centre

Budget £15k, may have £4k to add from unused STSM budget (more trainees)

People can be told straight away if they are accepted (first person per country) or if they are on the waiting list.
